**Medication Coverage Notice**

Dear Member Name,

We are writing to tell you about important changes to coverage of one of your medications.

Starting January 1, 2017, Blue Cross and Blue Shield of North Carolina (BCBSNC) will be removing certain medications from the Medication Dedication program. These medications will remain covered but will no longer be offered at no charge. The cost of these medications will depend on which tier they are listed on in the health plan's drug formulary. The impacted medications are listed on Page 2 of this letter. Our records show that you filled a prescription for one or more of these medications in the past 4 months. Please ignore this letter if you no longer take this medication.

**What do I need to do?**

The medications listed on Page 2 will continue to be covered; however, they will require you to pay the applicable copay / deductible and coinsurance according to your pharmacy benefits.

We would encourage you to talk to your doctor about this change. You and your physician may find more information about covered medications at

**Why is this change being made?**

BCBSNC is making efforts to control the cost of medications, which can change on a regular basis. In order to keep the program active but better manage costs, BCBSNC reviewed the medications in the program removing the high cost brands and generics where there are suitable lower cost alternatives.
